### 1. General

- 1.1 This Privacy Statement describes how the Controller processes the personal data of its Users.
- 1.2 The personal data that are processed by the Controller are [name, address, email address, phone number, etc.].

### 2. Collection and use of personal data

- 2.2 The Controller uses this personal data for the purpose for which Users have provided the Controller with the personal data:

### 3. Transfer to third parties

3.1 The controller will not pass on the personal data of its Users to third parties, unless:

3.1.1 the transfer is made to a processor engaged by the Controller for the purposes listed in this Privacy Statement and the Controller has concluded an agreement with the processor that ensures that the processor offers sufficient guarantees in respect of the technical and organisational security measures with regard to the processing to be carried out; or

3.1.2 The Controller is obliged to pass on the personal data to competent authorities on the basis of a legal obligation.

### 4 Cookies

### 5 Amending / deleting personal data
